Roman Law System (EU)

- English Common law system allows for either of two things
 - 1. Monarchy
 - 2. Elected President
- The important part is the Constitution and Common Law.
- The only Country in the British Isles that can have this system is England, with Wales as a Principality and Northern Ireland as Crown Dependency (but completely self governing like Isle of Man and Guernsey).
- Scotland is a separate Country with Roman Law. EU Law. It is NOT compatible with English Common Law.

Roman Law

- Scotland has Roman Law (the opposite to Common Law)
- The British have tried to force Roman Law on the English.
- The EU is Roman Law.
